Cremation will take place within five days of receiving a California Disposition Permit. Standard Cremation is based upon deceased being under 250 lbs.

This fee includes responding to the initial request for service, conducting the arrangement conference, preparing the statistical data, filing of permit and other legal documents.

Includes the removal of the decedent from a hospital, coroner's office, nursing home or residence within the counties listed above, sheltering the decedent in refrigeration, completing a signed death certificate, filing the certificate and permit with the local health department, alternative container, cremation process, one (1) utility urn and returning the cremated remains back to the next of kin. If you want to arrange for a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard or composition materials (with or without the covering). The containers we provide are fiberboard. **We are able to provide this service for decedents who weigh up to 250 lbs. Services can be provided, for additional fees, for decedents exceeding 250 lbs or for decedents who do not fit in a standard cremation container.**
